“NOTICE”

To effectively address the concerns/grievances/representations of retired employees of NPCIL, a web portal named **Pariwar Connexion (Retired Employee Web Portal System)** was developed and in use since 2013. The primary purpose of this web portal is to provide single window facilitation for registering, monitoring & timely resolution of grievances/representations of retired employees of NPCIL.

Keeping in mind the changing situation and as part of streamlining the existing system, the following changes have been made in the “Pariwar Connexion” web Portal to extend best possible service to the retired employees of NPCIL: -


- The existing software module is modified to provide better user experience. To avail the services, retired employees have to register themselves in “Pariwar Connexion” web portal available under www.npcil.nic.in providing some basic information. After verifying necessary credentials, Nodal Officer, CPC will approve the employee for use of “Pariwar Connexion” web portal & an email/SMS Message on the same will be sent to the concerned retired employee. Subsequent to successful registration, authorized retired employees can avail the services under “Pariwar Connexion” web portal.
- The concerns/grievances/representations can broadly be registered under the heading Pension, CHSS, ID Card and General and will be addressed to Chief Nodal officer.
- Immediately on receipt of the concerns/grievances/representations, the Pariwar Connexion web portal will send an acknowledgement to the Applicant. Chief Nodal Officer of Pariwar Connexion at HQ will analyse the same and forward to the concerned Nodal Officer of Sites/Stations/HQs who in turn will examine the issue as per established rules and procedures and an appropriate response will be sent to the applicant directly and copy to Chief Nodal Officer at HQ within a reasonable time.
- Chief Nodal officer at HQ will follow up with concerned Sites/Stations/HQs Nodal Officers regarding status of the pending concerns/grievances/representations and maintain proper record of such matters.
- Chief Nodal officer at HQ shall also bring to the notice of ED (HR) all such concerns/grievances/representations, which are pending more than a month for early resolution. Chief Nodal officer at HQ will submit quarterly reports to ED (HR) on the status of disposal of such concerns/grievances/representations.

- The representations received through CPGRAMS will continue to be dealt with by concerned Authority only. Any grievances related CPGRAMS will not be entertained in this “Pariwar connexion” web portal and will be rejected.
- To update about new policies/decisions of Company, options have been added to view various in-house magazines of NPCIL and view relevant Company circulars.
- Blanks forms related to retired ID cards with concerned officials to whom the filled form to be sent and other blank forms related to retired employees have been made available for their use.
